CONFLICT DATES AND INFORMATION ON ELECTRICAL SUPPLY**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company), and for its Response to the Missouri Public Service Commission (Commission) Order Soliciting Conflict Dates and Information on Electrical Supply, provides the following:

1. AmerenUE is not available on Monday, April 13; Friday, April 17; Monday, April 20; Tuesday, April 28; or Tuesday, May 5, 2009.
2. It is AmerenUE’s understanding that Cuivre River Electric Cooperative will continue to provide temporary electric service to the Wests. However, AmerenUE is unclear if the temporary facilities are sufficient to provide service during the air conditioning season.

WHEREFORE, the Company respectfully requests that the Commission schedule the pre-hearing conference on a date consistent with the above listed conflicts.
