## LACLEDE GAS COMPANY'S RESPONSE TO STAFF'S RECOMMENDATION

COMES NOW Laclede Gas Company ("Laclede" or "Company") and submits this Response to the Recommendation filed on November 8, 2007 by the Staff of the Missouri Public Service Commission ("Staff"). In support of its Response, Laclede states as follows:

- 1. On August 31, 2007, Laclede filed an application to abandon L.P. Gas Service to customers in the Meadowview Acres Mobile Home Park in Jefferson County, Missouri ("Application"). In its Recommendation, Staff recommends that the Commission grant Laclede's Application, subject only to the condition that the Company recognize the amount of \$2,000 as the net salvage value for certain propane storage tanks booked to the Company's plant-in-service.
- 2. Although Laclede does not necessarily agree that it is appropriate to recognize a net salvage value associated with the storage tanks, due to a lack of materiality it does not object under the limited facts of this case to Staff's recommended condition for granting the Company's application.
- 3. Accordingly, Laclede respectfully requests that the Commission act as expeditiously as possible to grant the Company's Application in this case subject to Staff's recommended condition.

WHEREFORE, Laclede Gas Company respectfully requests that the Commission act as expeditiously as possible to issue its order granting Laclede's Application to Abandon the provision of General L.P. Gas Service to customers in the Meadowview Acres Mobile Home Park in Jefferson County, Missouri upon the terms and conditions set forth in such Application, subject to Staff's recommended condition.
