On May 10, the parties filed a Status Report Agreement Regarding Consolidation and a Proposed Procedural Schedule. That Agreement provided as follows:

“By no later than July 2, 2018, Confluence Rivers shall file its Amended Application (the parties request that the Commission set a new intervention deadline and issue its traditional Order Directing Notice, such as was issued herein on November 3, 2017, regarding any additional service areas included in the Amended Application)”.

That Agreement provided, further, that Staff was to file a supplemental recommendation on the Amended Application within 60 days after the Amended Application was filed. On July 3, 2018, Confluence Rivers filed a Motion for Leave to Amend Application and [proposed] Amendments to Application (“Motion for Leave to Amend”), which the Commission sustained on July 17, 2018. Accordingly, Confluence Rivers’ Amended Application will be deemed to have been filed, per the Commission’s Order granting leave, on July 17, 2018.

THE COMMISSION ORDERS THAT:

1. The Staff of the Commission shall file a Supplemental Recommendation no later than, or an alternative pleading no later than September 17, 2018.

2. This order shall be effective when issued.




