ORDER SCHEDULING A PREHEARING CONFERENCE

On August 10, 2007, at the request of the parties, the Commission suspended the procedural schedule for this case in response to the filing of a nonunanimous stipulation and agreement in Missouri-American's rate case, WR-2007-0216. That nonunanimous stipulation and agreement contained terms that also purported to settle all issues regarding the capacity charge tariffs at issue in this case. An objection was made to that nonunanimous stipulation and agreement, and it is not clear what effect that objected-to stipulation and agreement can have on this case. The Commission must determine very soon whether it needs to hear additional testimony in this case. To that end, the Commission will schedule a prehearing conference to discuss these questions with the parties.

IT IS ORDERED THAT:

1. A prehearing conference shall be held on September 6, 2007, beginning at 2:00 p.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This conference will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. If you need
