Herzog Homes bill showed up on my 2/21-3/22/07 bill. Mr. Herzog called the Laclede Gas customer service and talked with a lady that would look into it. He never received a call back. When I paid our house bill I sent a letter (1) asking for information. I received no response.

On my checks for 3/22-4/23/07 (2) and 4/24-5/22/07 (3) I made notations. No response.

On June 11th Mr. Herzog contacted Laclede Gas again. On June 19th I sent a letter to Missouri Natural Gas. (4) with the attached house settlement statements and a legal document stating we were not responsible for any bills on these houses. I received no response.

On July 3, 2007. I sent the same information to Laclede Gas. This was enclosed with my payment. They cashed my payment so they had to have gotten my letters.

Based on the information that was on your web site I should have gotten a phone call in regards to this matter. I received none. There was no message on our answering machine either.

I am sending the same information to Laclede Gas along with a copy of your letter. Laclede Gas had no right to turn off our personal residence gas. I paid the bills for our home on time.
