# ORDER GRANTING CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE PRIVATE PAY TELEPHONE SERVICE

Issue Date: December 5, 2017 Effective Date: December 5, 2017

On November 16, 2017, CenturyLink Communications, LLC ("CenturyLink") filed an application with the Commission requesting a Certificate of Service Authority ("CSA) to provide private pay telephone service. The Commission issued notice of CenturyLink's application and set a December 4, 2017 deadline for the filing of applications to intervene, but no applications were received. The Commission will therefore consider CenturyLink's uncontested application.

CenturyLink is a Limited Liability Company with its principal place of business located at 100 CenturyLink Drive, Monroe, Louisiana. CenturyLink seeks authority to install, operate, control, manage, and maintain private pay telephone(s) within the State of Missouri. CenturyLink requests that such authority also apply to additional locations that may be served by CenturyLink in the future. CenturyLink agrees to provide a complete list of served locations if the information is requested by the Commission's Staff.

Pursuant to Section 392.520, RSMo 2016, and Commission Rule 4 CSR 240-28.030, the Commission has jurisdiction over the provision of customer-owned

coin telephone telecommunications services and may grant a CSA to provide payphone service.

Finding competition in the private pay telephone service market to be in the public interest, the Commission shall grant a CSA to CenturyLink. The provision of private pay telephone service is classified as competitive and subject to minimum regulation pursuant to Section 392.520, RSMo 2016.

## THE COMMISSION ORDERS THAT:

- CenturyLink Communications, LLC is granted a certificate of service authority to install, operate, control, manage, and maintain private pay telephone service in the State of Missouri.
- CenturyLink Communications, LLC shall comply with all conditions listed in Paragraph 4 of the company's application and with all applicable regulations of the Commission.
  - 3. This order shall become effective when issued.
  - 4. This file shall close on December 18, 2017.
