RESPONSE TO RETURN SERVICE OF PROCESS

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and provides this response to the "Return of Service of Process" filed in this case file on July 16, 2007.

1. The Commission canceled the certificates of service authority and tariff of Kataman Communications, L.L.C. in its order of July 9, 2007. The Commission sent a copy of its *Order Canceling Certificates and Tariff* to the address provided by the Staff as the registered agent of Kataman Communications, L.L.C. The Corporation Service Company, who apparently was the ultimate recipient of the document sent to the address provided by the Secretary of State as the registered agent, responded that they could not receive the service because they were not the registered agent.

2. The address used by the Commission, and also by Staff for service of its initial *Motion to Cancel Certificates of Service Authority and Tariff*, is that provided by the Secretary of State as that of Kataman Communications, L.L.C.'s registered agent. See Attachment A.

3. Moreover, as Kataman Communications, L.L.C. requested cancellation of its certificate, a copy of the *Motion to Cancel* as well as a copy of the Commission's *Order* were also sent directly to the company at the address the company provided to the Commission at:

Accordingly, the company did receive actual notice of the filing and order in this case and no prejudice should arise.

WHEREFORE, Staff submits that the Commission has properly served the company's registered agent and recommends that the Commission close this case.
