1	Q.	Please state your name and residence address.
2	A.	Alvin and Jill Drennen, Route 1, Box 77, Freeburg, Missouri 65035.
3	Q.	Are you a property owner in one of the three counties through which Union Electric
4		Company is applying for permission and authority to construct, operate, own and maintain
5		a 345 kilovolt transmission line?
6	Α.	Yes, in Osage County.
7	Q.	What is the purpose of your testimony?
8	A.	I am providing this testimony in opposition to the application to construct this transmission
9		line on the route requested by Ameren UE. The law requires that construction of this power
10		line must be shown by Ameren UE to be necessary and convenient for the public service.
11		Regardless of any necessity for a transmission line somewhere else, it is neither necessary
12		nor convenient to the public to build this proposed line. The line can be constructed in other
13		areas and its construction in the place and manner proposed will be destructive of family
14		farms, family values, and does irreparable harm to the history and heritage of the local area
15		and its surrounding communities. If this proposed line goes through, it will take the home
16		which we now reside in. Our home which we have lived in for the last seven years and
17		hoped to retire in someday. The home which we raise our two small children near family and
18		friends. No amount of money can replace the bond and history we have with this
19		community.
20	Q.	Are you a member of the Intervenor group known as Concerned Citizens for Family Farms

and Heritage?

- A. Yes, I am a member of that group and offer my testimony in support of its statement of
 purpose, which is attached to this testimony and incorporated.
- Q. Have you as a property owner in the path of the proposed transmission line been contacted
 by Ameren UE for purpose of discussing where the line would go through your property and
 what alternatives, if any, might be available?
- 7 A. We were informed by our neighbor after he attended one of the local workshops, which we 8 were not invited to, that the proposed line would take out our home. We had to make the 9 initial contact to Ameren UE to find out if this was the case. After several contacts, we were informed by Ameren UE that the route they were proposing would take out our home. We 10 11 were then visited by an Ameren UE representative (after we requested this visit) and was told 12 that there was no alternative route available and it was a "done deal" and there wasn't 13 anything we could do but to settle with them as soon as possible. We were informed that the 14 project would start this summer and the sooner we settled the more time we would have to 15 find another place to go. When we asked Ameren UE how much time we had before we would have to move, they would not give us a date. They told us that their deadline to start 16 17 this project was coming up and we were running out of time.
- 18 Q. How long have you owned the property in question?
- 19A.We purchased the property in October, 1995. We were lucky to be able to buy this home,20since homes in this area rarely are sold. Most of these homes are handed down to children21and family. I (Jill) grew up in this community and my dream was to move back to this area22and raise my two children in a quiet, friendly community and give them an opportunity to

1		attend a small Catholic school. My parents, aunts, uncles, and cousin all live in this area.
2	Q.	Could you describe the nature of the property and its past and current use?
3	А.	This home was built in the late 70's and was owned by Vince and Pearl Mengwasser until we
4		purchased it in October, 1995.
5	Q.	Is the proposed transmission line to run near or over any residence, structures, or
6		improvements to your property?
7	А.	Yes. It will take out our home.
8	Q.	Do you already have any power lines over your property?
9	А.	Yes. We have one in the front of our property and one down each side of our property.
10	Q.	Will the proposed power line, if built, affect the value of your land?
11	А.	Yes. A power line of this size on my property will without question decrease the overall
12		value of my property. To sell our property is not an option that we have, unless we sell it to
13		Ameren UE. The community in which we live in does not have a high retail market for
14		homes or property. All or most of this land has been owned by families in this community
15		for many generations. People value their property and land in this area and are not willing
16		to sell to anyone. If we are forced to sell our home to accommodate Ameren UE in regards
17		to this transmission line, we will have to move to another community. This will involve
18		leaving family and friends behind and also sending my children to another school. If we
19		decide not to sell our property to Ameren UE and move our home to another portion of our
20		property, we face the health affects of such a power line. Although I am unsure of the health
21		affects of such a large power line so close to my own daily activities, it is ingrained in the
22		popular mentality that such power lines constitute a health hazard that I will not risk on my

children.

Q. What other adverse impacts do you feel this line will create for yourself and others?

3 Α. The attached statement of purpose for Concerned Citizens for Family Farms and Heritage sums up the overall bad impact. I and my neighbors live where we do by choice. We forego 4 5 the luxuries of more urban living in exchange for the peace, quiet and more rustic lifestyle of the family farm and the small local community. The threat of this power line has already 6 devastated our family, through stress and anxiety not knowing where we will live if this 7 8 proposed line application is approved. The stress of being told that it is a "done deal" and 9 explaining to my children why we might have to move is not a burden that is easy to bear. 10 This stress has caused my husband to have migraine headaches and our children to have fear 11 of losing their friends and leaving the school that they are attending. There is not a day that goes by that we do not think about what will happen to our lives if this power line application 12 13 is granted.

Q. Do you know of any alternatives to the Ameren UE proposal which might change your
opinion about this project?

A. The alternatives are all within the power of Ameren UE to implement, and I do believe an alternative exists. I believe Ameren should restudy the route and balance the interests of the community against their need to relieve overloading problems. There are other corridors equally available to Ameren to build this line which would be better able to bear the burden of the line's presence without destroying property values, life styles and family farms. My neighbors and I have no alternatives, and construction of the line as proposed will change our lives and circumstances forever. We will not be able to sell even though we may not wish

to stay. Given our lack of options and alternatives, and the numerous alternatives available to Ameren UE to put this line almost anywhere it wants, it is my hope that the Public Service Commission will require Ameren UE to balance their mere commercial need against our vital need to preserve the family farm and our way of life.

- 5 Q. Have you had past experiences with power companies and their maintenance of their 6 easement and right-of-way, and do you have concerns about this aspect of the new power 7 line?
- 8 A. We have had no past experiences with this matter, but I have been informed by other 9 neighbors that there have been problems in the past with damaging of property, leaving trash, 10 and not notifying the property owners before any timber is cut or pesticide is sprayed.
- Q. Do you have any further testimony or observations to make for the Public Service
 Commission?
- 13 A. We feel that we have been misled by Ameren UE regarding this proposed line. As stated 14 before, we were never contacted about the workshops that were offered in November and 15 February. The first contact that we had regarding this proposed line was through a neighbor 16 that attended one of these workshops and informed us that the proposed plan would put the 17 power lines over the top of our home. After several attempts to contact Ameren UE, we were 18 informed that the proposed line would involve the removal of our home. We then had to 19 "request" a meeting with Ameren UE to discuss this matter further. We were told that it was 20 a "done deal" and that no alternatives were available. We were also told that it would be in 21 our best interest to settle with them as soon as possible and that they were only required by 22 law to give us a "fair market value" for our home. This seems a little unfair to us,

considering that we are being FORCED out of our home without choice, having to start all over again regarding home loan, new community, new school, etc. Not to mention the stress and anxiety it has caused our whole family not knowing when or if this proposed line will go through. There is not a day that goes by where we don't feel the pressure of this proposed line and the situation that we may be faced with if this application is approved. We feel that it is not right to give a "private" company the power of eminent domain that will be building a 345,000 kV line that will not even benefit the surrounding counties in which it will reside. We are taxpaying citizens and have worked hard for the property and home that we have and feel that our freedom to live where we choose is being taken away from us. We are also concerned about the health risks that are involved if the line is moved to miss our home and we have to live in close vicinity to this power line. My children deserve a safe environment in which to grow.
