ORDER GRANTING MOTION TO CONSOLIDATE

On November 2, 2016, the Staff of the Missouri Public Service Commission filed a motion requesting the Commission consolidate File Nos. SR-2017-0109 and WR-2017-0110 in the interest of administrative efficiency and economy of resources. The Commission issued an order setting a deadline for interested parties to file a response, but no responses were received.

Commission Rule 4 CSR 240-2.110(3) allows for the consolidation of pending actions that involve related questions of law or fact. Because these cases involve a related request for revenue increases for the same utility, the Commission will grant the requested relief.

THE COMMISSION ORDERS THAT:

1. Staff's Motion to Consolidate File Nos. SR-2017-0109 and WR-2017-0110 is granted, with WR-2017-0110 being the lead case.

2. This order shall be effective when issued.


