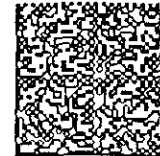

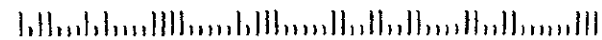

ORDER OF CORRECTION

On May 29, 2009,¹ The Empire District Electric Company ("Empire") and the White River Valley Electric Cooperative ("White River") (collectively "Applicants") filed a joint application ("Application") requesting that the Commission approve an addendum to their territorial agreement. The addendum would allow White River to provide electric service to a single lot that is currently situated in Empire's service territory.²

On June 1, the Commission issued notice, set an intervention deadline and directed filings by the parties. In ordered paragraph number 3, the Commission directed the Applicants to provide the name and mailing address of the owner of the lot at issue so that the Commission could mail a copy of the notice to that individual. It has come to the Commission's attention that this information was already provided in an appendix to the application. Consequently, the Commission shall rescind that directive.

Believing the mailing information would be submitted at a later date, the Commission also directed its Data Center, in ordered paragraph number 4 of the order, to overnight the notice to the lot owner as soon as the owner's mailing address was

made available. Because that information is currently available, the Commission shall also rescind the requirement that its Data Center overnight the notice to the lot owner. A copy of the June 1 notice may be mailed to the lot owner in the ordinary fashion utilizing the mailing address for the lot owner provided in Appendix C to the Application.

THE COMMISSION ORDERS THAT:

1. Ordered paragraph's numbers 3 and 4, of the Commission's June 1, 2009 order captioned: "Order Directing Notice, Establishing Deadline for Filing Recommendations, Setting Date for Intervention Requests and Setting Date for Filing a Procedural Schedule," are hereby rescinded.
2. This order shall become effective immediately upon issuance.
