- General Rate Increase

Dear Mr. Roberts:

WR-2000-281 and 5R-2000-282

Enclosed for filing on behalf of the Missouri-American Water Company, please find three copies of the revised tariff sheets as listed on Appendix 1 attached hereto.

The purpose of this filing is to implement a general rate increase for water and sewer service provided by Missouri-American. The revised water rates were designed to produce an additional \$16,446,277 in gross annual water revenues (excluding gross receipts and sales taxes) or a 53.97% increase over existing water revenues. The revised sewer rates were designed to produce an additional \$2,363 in gross annual sewer revenues or a 5% increase over existing sewer revenues.

In addition, attached hereto as Appendix 2, are fifteen copies of Missouri-American's Minimum Filing Requirements as required by Commission Rule 4 CSR 240-10.070.

Please note that the attached tariff sheets bear an issue date of today and are proposed to become effective for service rendered on and after November 15, 1999.

Please see that this filing is brought to the attention of the appropriate Commission personnel. Two copies of the attached are being filed with the Office of Public Counsel and a copy is also being sent to parties of record in Company's last general rate case. Thank you for your cooperation in this matter.



Cottleville, Missouri, October 15, 1999 – Missouri-American Water Company today asked the Public Service Commission for new rates to recover the increased costs of making company-wide capital improvements to water treatment facilities and distribution systems.

"We have and will continue to make the investments necessary to meet the needs of our customers," said William Hardy, manager. "We remain committed to providing reliable, high quality water service. Our request for new rates is to recover the cost of capital investments throughout our system that are critical to providing quality drinking water now and in the future."

The company invested \$93 million in statewide capital improvements in 1998 and 1999, including several water main relocation projects in St. Charles County designed to support the rapid growth and economic development in the area.

If the new rates are approved as submitted, the water bill of the average residential customer the St. Charles district will increase about \$11.88 per month, to \$33.79. This increase would not take effect until late 2000. Missouri-American has not requested a rate increase since 1996.



St. Joseph, Missouri, October 15, 1999 – Missouri-American Water Company today asked the Public Service Commission for new rates to recover the increased costs of making company-wide capital improvements to water treatment facilities and distribution systems.

"We have and will continue to make the investments necessary to meet the needs of our customers," said Robert Amman, manager. "We remain committed to providing reliable, high quality water service. Our request for new rates is to recover the cost of capital investments throughout our system that are critical to providing quality drinking water now and in the future."

The company invested \$93 million in statewide capital improvements in 1998 and 1999, including the construction of a new 30 million-gallon per day groundwater treatment facility in St. Joseph. This plant is scheduled for completion in spring 2000.

The company also is asking the commission for a change from quarterly to monthly billing to order to make bill paying more affordable and improve customer service. If the new rates are approved as submitted, the water bill of the average residential customer in St. Joseph will increase about \$8.59 per month to \$25.61. This increase would not take effect until late 2000. Missouri-American has not requested a rate increase since 1996.

Missouri-American Seeks New Rates to Recover Costs of Providing Quality Drinking Water

Warrensburg, Missouri, October 15, 1999 – Missouri-American Water Company today asked the Public Service Commission for new rates to recover the increased costs of making company-wide capital improvements to water treatment facilities and distribution systems.

"We have and will continue to make the investments necessary to meet the needs of our customers," said Robert Amman, manager. "We remain committed to providing reliable, high quality water service. Our request for new rates is to recover the cost of capital investments throughout our system that are critical to providing quality drinking water now and in the future."

The company invested \$93 million in statewide capital improvements in 1998 and 1999, including the construction of a new \$4.2 million plant improvement project scheduled for completion in spring 2000. The plant will employ a state-of-the-art ozonation treatment process designed to remove hydrogen sulfide, improving the odor and taste of customers' drinking water. Other Company projects include the construction of a new well and shaft replacement for an existing well.

If the new rates are approved as submitted, the water bill of the average residential customer in Warrensburg will increase about \$8.59 per month, to \$25.61. This increase would not take effect until late 2000. Missouri-American has not requested a rate increase since 1996.

MISSOURI-AMERICAN WATER COMPANY STATEMENT OF REASON FOR RATE INCREASE

In order to meet continuing demand for adequate service, Missouri-American has been and will continue to be required to expend money to assure a continued adequate source of supply, to renovate its existing facilities, to improve and enlarge its facilities and to reinforce and extend its distribution system. The increase in the cost of service and the additional capital expenditures have not been offset by the additional income produced by the increase in rates effective November 14, 1997 in Case No. WR-97-237/SR-97-238, and, as a result, Missouri-American will experience a significant erosion in its earnings. An increase in its rates is essential for Missouri-American to maintain a reasonable level of service, to meet the expanding needs of its service area and to have a reasonable opportunity for appropriate earnings. Missouri-American must have income to sufficiently and properly provide for all expenses of an efficient public utility, to market its securities, to attract replacement capital for maturing debt and to attract new capital, all at reasonable costs. The rates presently charged by the Company are insufficient to meet its requirements, because they no longer are compensatory and are therefore unfair, unreasonable and unjust.

Since its last rate case, Missouri-American Water Company's rate base investment will increase by approximately \$96,000,000. The major part of this increased investment is due to St. Joseph Treatment Facilities \$74,684,000, Warrensburg Hydrogen Sulfide removal plant \$4,500,000, Mexico plant improvements of 5,050,000. The Company's annual operating costs, net of increased revenues, will increase by approximately \$16,446,000.
