

## STATE OF MISSOURI PUBLIC SERVICE COMMISSION

At a Session of the Public Service Commission held at its office in Jefferson City on the 17th day of December, 1991.

In the matter of Union Electric Company's proposed ) tariff to modify the Rate Application paragraph ) CASE NO. ER-92-132 of Service Classification No. 6(M).

#### SUSPENSION ORDER AND NOTICE OF PROCEEDINGS

On November 18, 1991, Union Electric Company (Company) filed tariffs to modify the Rate Application paragraph of Service Classification No. 6(M) Street and Outdoor Area Lighting - Customer Owned. As stated by the Company, the purpose of the modification is to clarify the wording in the Rate Application paragraph so as to eliminate any confusion that may be caused to their customers.

The Commission is of the opinion that it needs additional information concerning the ramifications of the proposed tariffs and has determined that the tariff will be suspended for a period of one hundred twenty (120) days beyond the requested effective date. The suspension of the tariff does not indicate that the Commission necessarily opposes the modification, but that more thorough review of the effect the proposal will have on customers and Company is necessary before a decision can be made regarding the reasonableness of the tariff.

The Commission is also of the opinion that the Executive Secretary of the Commission should serve a copy of this order upon the Mayor of each city and the County Commission of each county in the Company's service area. In addition, the Executive Secretary shall send notice of this order to the publisher of each newspaper located in the counties in which the Company provides service, as listed in the Newspaper Directory of the current Official Manual of the State of Missouri, and

to the members of the General Assembly representing the Missouri area served by the Company.

Any city, county, or other proper entity desiring to intervene in this proceeding shall file its application to intervene on or before the date set in this order and shall serve a copy of the application on the Company's attorney, William E. Jaudes, 1901 Chouteau Avenue, P. O. Box 149, St. Louis, Missouri 63166.

The Commission is further of the opinion that the Company should give notice to all customers affected by the modification of the existing tariff. Company with consultation with Staff will attempt to determine all affected customers and provide these customers with proper notice.

The Commission will schedule a prehearing conference to allow the parties the opportunity to discuss any substantive or procedural issues in this matter. The parties shall also utilize the prehearing conference to establish a procedural schedule to be presented to the Commission.

### IT IS THEREFORE ORDERED:

- 1. That the proposed tariff sheets submitted on November 18, 1991, by
  Union Electric Company for the purpose of modifying the Rate Application paragraph of
  Service Classification No. 6(M) be hereby suspended for a period of one hundred
  twenty (120) days from December 18, 1991, to April 17, 1992, unless otherwise ordered
  by the Commission.
- 2. That any proper entity desiring to intervene and participate herein shall, except for good cause shown, file its application to intervene and serve a copy of same upon the Company's attorney on or before January 17, 1992.
- 3. That the Company shall provide notice of these proceedings to each affected customer.
- 4. That a prehearing conference in this matter be hereby scheduled for January 27, 1992, at 10:00 a.m., in the Commission's offices on the fifth floor of

the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri. That the parties shall file a proposed procedural schedule with the Commission on or before January 30, 1992.

- 5. That the Executive Secretary of the Commission shall serve a copy of this order and provide notice as set forth herein.
  - 6. That this order shall become effective on the date hereof.
