- 2. Pursuant to the Commission's small utility rate case procedure, 4 CSR 240-3.050 (23), "[i]f at any time after a case is opened the utility and the staff agree that an increase in the utility's annual operating revenues is not necessary, or if the utility advises the staff that it no longer wishes to pursue an increase, the staff shall file a verified statement to that effect in the case file, whereupon the regulatory law judge *shall issue a notice closing the case*." (emphasis added).
- 3. Attached hereto is Staff's affidavit as to its knowledge of the Company's request to withdrawal its request for a rate increase.
- 4. Additionally, 4 CSR 240-2.116 (1) provides "[a]n applicant....may voluntarily dismiss an application....without an order of the commission at any time before prepared testimony has been filed or oral evidence has been offered, by filing a notice of dismissal with the commission and serving a copy on all parties."
 - 5. Neither prepared testimony has been filed or oral evidence taken in this matter.

WHEREFORE, the Staff files this Response and prays for the Commission to take

notice of West 16th Sewer Company's withdrawal of its rate increase request.
