## **ORDER SETTING LOCAL PUBLIC HEARING**

On June 4, 2009, the Commission granted the Office of Public Counsel's request for a local public hearing in this matter. The Commission, having secured a location for the hearing, shall set the date for the local public hearing for Wednesday, July 1, 2009. At the hearing, the Staff of the Commission will hold an informal question-and-answer session beginning at 11:30 a.m. The hearing will begin at 12:00 noon, and will conclude when every person who wishes to testify has done so.

**THE COMMISSION ORDERS THAT:**

1. The Commission gives notice that it shall hold a local public hearing on July 1, 2009, beginning at 12:00 noon. A question-and-answer session will be held before the hearing beginning at 11:30 a.m.
2. The local public hearing shall be held in the Youth Area of the First Baptist Church, 11 West Caster Street, Dexter, Missouri 63841.
3. No later than June 19, 2009, R.D. Sewer Company, L.L.C. shall mail notice of this hearing consistent with this order, said notice being approved by the Staff of the Commission and the Office of the Public Counsel before it is mailed, as required by

Commission Rule 4 CSR 240-3.050(18). Staff shall file a copy of the notice in these cases no later than June 24, 2009.

4. Customers wishing to make written comments or secure additional information may contact the Office of the Public Counsel, Post Office Box 2230, Jefferson City, Missouri 65102, telephone (573) 751-4857. Comments may also be registered in this case using the Internet Electronic Filing System at <http://psces/mpsc/>. Use the link to the Public Comment section and fill in all required fields on the comment page.

5. The local public hearing shall be held in a facility that meets the accessibility requirements of the Americans with Disabilities Act. Any person who needs additional accommodation to participate in the hearing should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 prior to the hearing.

6. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commissions of Stoddard County, Missouri.

7. The Public Information Office of the Missouri Public Service Commission shall make notice of this order available to members of the General Assembly representing the residents in the service area of R.D. Sewer Company, L.L.C., and to the news media serving the residents of that service area.

8. No later than July 9, 2009, the Staff of the Commission shall file a pleading as required by Commission Rule 4 CSR 240-3.050(19).

9. No later than July 16, 2009, the Office of the Public Counsel shall file a pleading as required by Commission Rule 4 CSR 240-3.050(19).

10. This order shall become effective immediately upon issuance.
