THE COMMISSION ORDERS THAT:

1. No later than December 28, 2009, the Staff of the Missouri Public Service Commission shall file a recommendation stating whether any, or all, of these matters may be consolidated pursuant to Commission Rule 4 CSR 240-2.110(3) to promote administrative economy and avoid unnecessary costs or delay.
2. If Staff does not recommend consolidation, it shall state, with particularity, why consolidation would not be appropriate.
3. Any party wishing to respond to Staff's recommendation shall file its response no later than January 4, 2010.

4. This order shall become effective immediately upon issuance.
