STAFF COMPANY AGREEMENT FOR 60 DAY EXTENSION

The Staff of the Missouri Public Service Commission (Staff) and MidMO Sanitation, LLC (MidMO or the Company) agree to the following:

1. Mid MO applied for a Certificate of Convenience and Necessity (CCN) in Case No. SA-2009-0319. In that case, Mid MO, the Office of Public Counsel (OPC), and Staff entered a Unanimous Stipulation and Agreement requiring Mid MO to commence a Small Utility Rate Case within ninety (90) days of the effective date of the Commission Order approving that agreement.
2. The Company is still waiting for an operating permit from the Missouri Department of Natural Resources (DNR). Without a permit, the Company cannot be certain of what DNR's requirements for the facility are and what items the Company will need to include in the contract between the Company and a certified sewer operator.
3. Commission Rule 4 CSR 240.3.050(12) allows Staff and the Company to extend the deadlines set out in sections (9), (10) and (11) for up to two (2) months.
4. Staff and Mid MO agree that it is necessary to extend the Small Utility Rate Increase process for sixty (60) days.
5. The Missouri Public Service Commission approved Staff's request for a 60 day extension on November 30, 2009.
