On April 9, 2010, the Staff of the Missouri Public Service Commission filed an agreement entered into with Mid MO Sanitation, LLC. The Office of the Public Counsel did not join in the agreement. On April 14, Mid MO filed a tariff sheet reflecting the proposed monthly rates, which are \$75.35, residential flat rate and \$113.01, commercial flat rate. The sheet has an effective date of June 1. Under Commission rule 4 CSR 240-3.050 (14) the company is required to mail notice of the rate change to its customers no later than April 19.

On April 15, Public Counsel filed a request for a local public hearing. In light of the fact that the company must notify its customers of both the change in rate and, as set by this order, notice of the local public hearing, Public Counsel also requests that Commission rule 4 CSR 240-3.050(14) be waived.

The Commission will grant Public Counsel's request for a local public hearing. And, to avoid the possibility of the company having to mail two notices, the Commission will grant Public Counsel's request for a waiver of Commission rule 3.050(14). Although the company may send notice of the tariff change and local public hearing after April 19, the Commission will require that customers receive such notice no later than April 23.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel's request for a local public hearing is granted.

The Office of the Public Counsel's request for a waiver of Commission Rule
4 CSR 240-3.050(14) is granted.

A local public hearing shall be held from 5:30 p.m. until 9:00 p.m. on April 29,
2010 at the following location:

Westminster College Hunter Activity Center in the Herman Lounge 501 Westminster Ave. Fulton, MO 65251

4. The hearing will begin with a question and answer session. After which, the Commission will take sworn testimony from any customers who wish to make an on-the-record statement.

5. The local public hearing shall be held in a facility that meets the accessibility requirement of the Americans with Disability Act. Any person requiring additional accommodation to participate in the hearing shall call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 prior to the hearing.

6. The Data Center of the Missouri Public Service Commission shall serve a copy of this order upon the county commission of Callaway County, Missouri.

7. The Public Information Office of the Missouri Public Service Commission shall make notice of this order available to members of the General Assembly representing the residents in the service area and to the local media serving therein.
