## SUPPLEMENT TO APPLICATION OF T-MOBILE CENTRAL LLC FOR DESIGNATION AS AN ELIGIBLE TELECOMMUNICATIONS CARRIER

COMES NOW T-Mobile Central LLC and hereby supplements its Application to the Commission for designation as an Eligible Telecommunications Carrier ("ETC") for the limited purpose of offering and receiving Federal Universal Service Fund ("FUSF") support for providing Low Income related services, including Lifeline and Link Up, to qualified low-income consumers within its service area in Missouri, stating as follows:

- 1. T-Mobile Central LLC filed its Application for designation as an ETC on December 22, 2011, and on December 23, 2011, the Commission issued its Order Directing Notice, Directing Filing and Setting Intervention Deadline ("the December 23 Order"). In Paragraph 4 of the December 23 Order, the Commission requires T-Mobile Central LLC to supplement its Application with information that it is authorized to do business in Missouri.
- 2. In the December 23 Order the Commission notes that the Application includes a certificate of registration from the Missouri Secretary of State for VoiceStream PCS I LLC, but does not include similar documentation for the Applicant, T-Mobile Central LLC. As demonstrated by Exhibit A attached hereto, on October 6, 2005, VoiceStream PCS I LLC filed with the Secretary of State an Amendment of a Foreign Limited Liability Company, stating that

the name of VoiceStream PCS I LLC had been changed to T-Mobile Central LLC. The third page of Exhibit A is the Secretary of State's certification, dated October 13, 2005, that the Certificate of Amendment had been filed and that T-Mobile Central LLC was doing business in Missouri.

3. Attached hereto as Exhibit B is a certificate of good standing from the Missouri Secretary of State, certifying that T-Mobile Central LLC is in good standing and may do business in Missouri.

Wherefore, T-Mobile Central LLC supplements its Application for ETC designation.
