MOTION TO CANCEL CERTIFICATES OF SERVICE AUTHORITY AND TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificates of competitive basic local and interexchange telecommunications service authority in Missouri of Cbeyond Communications, LLC ("the Company") and states as follows:

1. On December 1, 2000, and February 22, 2001, the Commission granted certificates of interexchange competitive basic local telecommunications service authority the Company in Cases No. TA-2001-259 and 260, and approved the current name (d/b/a Birch) in Cases No. XN-2015-0099 and CN-2015-0098, respectively. It has existing approved tariffs, JL-2002-0270 and JL-2002-0271.

2. On March 26, 2015, the Company notified the Commission that it no longer wished to retain its certification to provide telecommunications services in Missouri (see the attached letter).

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificates of service authority of Cbeyond Communications, LLC to provide competitive basic local and interexchange telecommunications service in Missouri and its tariffs.
