STAFF'S MOTION TO EXTEND FILING DEADLINE

COMES NOW the Staff of the Missouri Public Service Commission, by and through Counsel, and for its Motion states:

- 1. On May 18, 2009, Entelegent Solutions, Inc., ("Entelegent") filed its Application for Certificates of Service Authority to provide basic local exchange, nonswitched local exchange, and interexchange telecommunications services in Missouri, and to classify said services and the company as Competitive.
- 2. The Commission directed the Staff to file a Recommendation as to the Application no later than June 30, 2009.
- 3. On June 30, 2009, Staff filed its Motion to Extend Filing Deadline, as at that time, Entelegent had not filed all information necessary to complete its Application.
- 4. On June 30, 2009, the Commission directed the Staff to file a Recommendation as to the Application no later than July 30, 2009.
- 5. To date, Entelegent has not filed all information necessary to complete its Application. In particular, certain financial information has not been provided.
- 6. Staff has contacted a representative of Entelegent, who has indicated that such information will be provided.

- 7. Absent the financial information, Staff is unable to recommend the granting of the Certificates and Designations requested in Entelligent's Application.
- 8. The Staff respectfully requests the extension of time to file its recommendation until August 14, 2009, to allow time for Entelligent to file the necessary information, and Staff to evaluate said information.
- 7. The Staff does not believe that any party will be harmed by the granting of its request for an extension of time to file its recommendation. The Staff does not make its request so as to unduly delay these proceedings.

WHEREFORE the Staff requests that the Commission grant it an extension of time from July 30, 2009 to August 14, 2009 for the filing of the Staff's recommendation in the instant case.
