MOTION FOR EXTENTION OF TIME TO FILE DISPOSITION AGREEMENT

COMES NOW the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Motion for Extension of Time to File Disposition Agreement*, states as follows:

1. On December 2, 2013, Hickory Hills Water & Sewer Company ("Hickory Hills") filed with the Commission a letter requesting approval of an increase in its annual sewer and water system operating revenues, pursuant to Commission Rule 4 CSR 240-3.050, *Small Utility Rate Case Procedure*.

2. According to the timeline filed by the Staff on December 5, 2013, Staff was required to file a disposition agreement between at least the Staff and the utility providing for a full or partial resolution of the utility's revenue increase request by May 1, 2014.

3. On April 30, 2014, Staff filed its first *Motion for Extension of Time to File Disposition Agreement* due to unusual complexities presented by the case and the necessity for additional time to work through these issues. Staff's motion was granted that same day and Staff was ordered by the Commission to file the disposition agreement no later than June 30, 2014.

4. Staff and the other parties have worked diligently to resolve the complex issues in this case and have recently formulated a proposed disposition agreement. However, the receiver for the utility is in need of additional time to review the agreement before it can be signed. As such, Staff respectfully requests that the deadline to file the disposition agreement be extended to July 7, 2014, to give the receiver an appropriate amount of time to review the proposed disposition agreement.

WHEREFORE, Staff prays that the Commission will grant its request to extend the deadline to file the disposition agreement to July 7, 2014.
