On September 28 2022, the Commission issued an *Order Approving Disposition Agreement and Implementing a Small Company Rate Decrease* in this matter, effective November 7, 2022. Along with other matters, that order approved a disposition agreement between S. K. & M. Water and Sewer Company (SK&M) and the Staff of the Commission (Staff) dated September 13, 2022, entitled, *Non-Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request* (Disposition Agreement).

The Commission will direct its Staff to provide a status report on whether SK&M has complied with the terms of the agreement and whether any further action or filings are expected in this file.

THE COMMISSION ORDERS THAT:

1. No later than February 24, 2023, Staff shall file a report on the status of SK&M's compliance with the Disposition Agreement approved by the Commission in this matter. Staff shall also advise the Commission on whether this file may be closed.
2. This order shall be effective when issued.
