STAFF'S REPORT

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and states the following in support of this *Report*.

- 1. On April 19, 2011, the Commission issued an *Order Regarding Request for Disclosure Pursuant to Commission Rule 4 CSR 240.3.640(5) ("Order")*. On April 26, 2011, a Concurring Opinion of Commissioner Jarrett was filed in this matter. This *Order* directed Missouri-American Water Company ("Missouri-American" or "Company") to re-classify the salaries of its officers as public information in its 2009 and 2010 Annual Reports no later than May 16, 2011.
- 2. On May 16, 2011, Missouri-American filed a notification in this case that the Company had reclassified the salaries of its officers as public information and submitted annual reports for 2009 and 2010 to be filed with the Commission in BMAR-2010-1486 and BMAR-2011-1358, respectively.
- 3. On May 16, 2011, the Commission issued an *Order Directing Filing* stating that Staff shall file a pleading confirming whether Missouri-American has complied with the *Order* no later than May 23, 2011. This pleading is meant to comply with that order.
- 4. Staff has reviewed the filings in BMAR-2010-1486 and BMAR-2011-1358 and states that those documents comply with the Commission's *Order* and further states that notification

filed by the Company in this case is sufficient to alert Complainant of where the desired information is located.

WHEREFORE, Staff respectfully submits this *Report* for the Commission's information and consideration.
