## ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: May 18, 2007 Effective Date: May 28, 2007

On April 16, 2007 the Staff of the Missouri Public Service Commission filed a motion to cancel the certificates of service authority granted to 3<sup>rd</sup> Wire Inc. Staff states that the Commission granted 3<sup>rd</sup> Wire a certificate of service authority to provide basic local telecommunications services in Missouri in Case No. TA-2001-414. The Commission also granted 3<sup>rd</sup> Wire a certificate of service authority to provide intrastate, interexchange telecommunications services and non-switched local exchange services in Case No. TA-2001-415. In both cases, the Commission granted the company waivers from having to file tariffs. The company has never filed a tariff and the Commission takes official notice of such.

Staff further states that according the Secretary of State's website, the company's registration was revoked on August 7, 2002 for failure to file its Annual Registration Report.

Additionally, Staff has contacted the company and has been informed that it has never conducted business in Missouri and does not intend to.

Under Commission rule 4 CSR 240-2.080(15) parties shall not be allowed more than ten days in which to file a responsive pleading. More than ten days have expired since Staff filed its motion and 3<sup>rd</sup> Wire has not responded.

Section 392.410.5, RSMo 2000, states: "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected. . . ." The Commission has reviewed Staff's motion and finds that granting the motion is reasonable. The Commission will therefore cancel the certificates of service authority granted to 3<sup>rd</sup> Wire in Case Nos. TA-2001-414 and TA-2001-415.

## IT IS ORDERED THAT:

- 1. The certificate of service authority to provide intrastate, interexchange and non-switched local exchange telecommunications services, limited to providing dedicated private line services, granted to 3<sup>rd</sup> Wire Inc. in Case No. TA-2001-415 is canceled.
- 2. The certificate of service authority to provide basic local telecommunications service granted to 3<sup>rd</sup> Wire Inc. in Case No. TA-2001-414 is canceled.
  - 3. This order shall become effective on May 28, 2007.
  - 4. This case shall be closed on May 29, 2007.
