ORDER CANCELING CERTIFICATES AND ACCOMPANYING TARIFF

Issue Date: September 7, 2010 Effective Date: September 17, 2010

On August 18, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting TON Services, Inc.'s ("TON Services") certificate of service authority and accompanying tariff to provide interexchange telecommunication services and the company's certificate of service authority to provide payphone service in the State of Missouri be cancelled. On August 23, 2010, Staff filed an amended motion which clarified the services to be cancelled.

In File Number TA-2000-188, the Commission granted TON Services a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

In File Number PA-2005-0349, the Commission granted TON Services a certificate of service authority to provide payphone telecommunication service in the State of Missouri.

Staff states in its motion that TON Services filed a letter which indicated that the company ceased operations and is no longer in business. Staff recommends that the Commission cancel the company's certificate of service authority to provide

interexchange and payphone telecommunications services, and the company's accompanying interexchange tariff.

On August 24, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than September 3, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request and Staff's motion, the Commission finds that the certificates of service authority and accompanying tariff granted to TON Services, Inc., shall be canceled.

IT IS ORDERED THAT:

- 1. The certificate of authority to provide interexchange telecommunications services granted to TON Services, Inc., in File Number TA-2000-188, is canceled.
 - 2. TON Services, Inc.'s tariff, P.S.C. MO No. 1, is canceled.
- 3. The certificate of authority to provide payphone telecommunications services granted to TON Services, Inc., in File Number PA-2005-0349, is canceled.
 - 4. This order shall become effective on September 17, 2010.

5. This case may be closed on September 18, 2010.
