**JOINT RECOMMENDATION**

COME NOW Sage Telecom, Inc. (Sage), and the Staff of the Missouri Public Service Commission (Staff) and for their Joint Recommendation, state as follows:

1) Sage and Staff jointly recommend the Commission permit the tariff revisions proposed in this matter to take effect on May 1, 2006, upon Sage's agreement to revise its customer invoice format to relocate the Public Switched Network Recovery Charge in a manner that resolves Staff's concern as stated in Staff's Response to Public Counsel's Motion to Reject Tariff, and as shown on the attached Appendix A.

2) Sage also agrees to two additional steps requested by Staff; namely, to update the Commission's mailing address on customer invoices and to revise the placement of the PSNR charge in its Welcome Package provided to new customers.

3) Based on these agreements, Staff and Sage have reached this Joint Recommendation that the tariff revisions should be approved.

WHEREFORE, Staff and Sage hereby recommend the Commission permit the revised tariff pages which are the subject of this case and tariff file No. JC-2006-0716 to either take effect on May 1, 2006, by operation of law upon expiration of the suspension ordered by the Commission in its March 30, 2006, Order, or by issuing an Order of the Commission approving the tariff sheets to take effect on May 1, 2006.
