ORDER DIRECTING SUPPLEMENTAL FILING

On October 29, 2021, Missouri RSA 5 Partnership a/k/a Missouri RSA No. 5 Partnership d/b/a Chariton Valley Wireless Services (“MO5”) filed a letter with the Commission to provide notice of its relinquishment of its designation as an Eligible Telecommunications Carrier (“ETC”), effective December 31, 2021. On November 19, 2021, Staff filed its *Staff Motion for Company to Supplement Request*.

Staff recommended that the Commission provide notice to other Missouri ETCs of MO5’s notice to relinquish its eligible telecommunications carrier status. Staff also recommends the Commission require MO5 to supplement its request with information: 1) as to whether the Company is ceasing all operations in Missouri; 2) the ability of all existing MO5 customers to switch service to another provider including the ability to retain their phone number and wireless device; and 3) pursuant to 47 U.S.C. Section 214(e)(4), explaining whether the purchase or construction of additional facilities by any of the remaining ETCs will be necessary to continue to serve the customers in that service area. Staff also asks the Commission to set a filing date for Staff’s recommendation at a date following MO5’s supplemental filing.

The Commission will direct MO5 to supplement its notice to relinquish its eligible telecommunications carrier status with the information called for above, and set a filing date for Staff's recommendation following MO5's supplemental filing.

THE COMMISSION ORDERS THAT:

1. No later than December 7, 2021, MO5 shall supplement its notice to relinquish its eligible telecommunications carrier status with information as to whether MO5 is ceasing all operations in Missouri; the ability of all existing MO5 customers to switch service to another provider, including the ability to retain their phone numbers and wireless devices; and, pursuant to 47 U.S.C. Section 214(e)(4), explaining whether the purchase or construction of additional facilities by any of the remaining ETCs will be necessary to continue to serve the customers in MO5's service area.

2. No later than December 14, 2021, the Staff of the Missouri Public Service Commission shall file with the Commission a recommendation regarding MO5's supplemental filing.

3. This order is effective when issued.
