 Applicant herein owns and operates a brewery in St. Louis, Missouri, and is now and for many years past has been a large consumer of (1) electric energy purchased from Union Electric Company of St. Louis, Missouri and (ii) natural gas purchased from Laclede Gas Company.

2. This proceeding involves the impact on Missouri utilities of the recently enacted Tax Reform Act of 1986. A preliminary review of the Act indicates that its implementation will result in a change in revenue requirements for either or both of these utilities. A change in revenue requirement of necessity involves rate design issues. These changes can affect the cost of utility service to Applicant and may be discriminatory. Applicant therefor has a direct interest in this proceeding.

3. It is the position of Applicant that appropriate procedures should be initiated so that any reduction in revenue requirement of the respective utilities as determined by this Commission herein or in any related proceeding may be promptly reflected in reduced rates determined on an appropriate cost of service basis.
