ORDER OF DISMISSAL

The instant case was filed on June 29, 1977, and set for hearing on
the 13th day of December, 1977. The hearing was subsequently continued to a
date to be fixed by the Commission.

The Commission, taking note of the fact that no request has been
received for resetting of this matter, is of the opinion that the case should be
dismissed pursuant to Rule 4 CSR 240-2.110(5), which provides that the Commission
may dismiss an application or complaint for want of prosecution if it has not
received, within ninety (90) days from the date of the order granting the
continuance, a request from the applicant or complainant that the matter be again
continued or set for hearing.

ORDERED: 1. That Case No. WM-77-231 be, and is, hereby dismissed.

ORDERED: 2. That this Order shall become effective on the 16th day
of January, 1979.


