MOTION TO HAVE TESTIMONY, AS FILED IN EFIS,
RECEIVED INTO EVIDENCE BY REFERENCE

COME NOW the undersigned Parties to this case (the “Parties”), and for their Motion to Have Testimony, as filed in EFIS, Received into Evidence By Reference, state as follows:

1. Pursuant to paragraph 23 of the now unanimous Partial Stipulation and Agreement filed in this case on July 23, 2010, as corrected on July 26, 2010, and paragraph 15 of the now unanimous Second Stipulation and Agreement filed in this case on August 3, 2010, the Parties agreed that all prefiled testimony and affidavits submitted in this case should be received into evidence without the necessity of the witnesses who sponsored these prefiled materials taking the stand.

2. Since all of the prefiled testimony, affidavits and associated schedules and exhibits submitted in this case already reside in EFIS, the Commission's electronic data base for regulatory filings, the Parties do not believe submitting additional paper copies of such documents (as would otherwise be required in an evidentiary hearing by 4 CSR 240-2.130 (13)), is necessary. Instead, the Parties recommend that such prefiled testimony, affidavits, and associated schedules and exhibits be received into evidence by reference as generally permitted by 4 CSR 240-2.130(1). This would include the prefiled testimony, associated schedules and exhibits currently designated in the EFIS file for Case No. GR-2010-0171 as EFIS Nos. 1 through 12; EFIS No. 14, EFIS No. 17, EFIS

Nos. 47 through 56, EFIS Nos. 59 through 61, EFIS Nos. 79 through 104, and EFIS Nos. 134 through 149.

3. The Parties further request the Commission grant any waiver of the requirements of 4 CSR 240.2.130 that might be necessary to implement this process.

WHEREFORE, for the foregoing reasons, the undersigned Parties respectfully request that the Commission implement paragraph 23 of the Partial Stipulation and Agreement and paragraph 15 of Second Stipulation and Agreement in this case consistent with the recommendation set forth herein.
