AMEREN MISSOURI'S REQUEST TO EXTEND DATE BY WHICH IT IS REQUIRED TO PROVIDE LED STREET LIGHTING INFORMATION

COMES NOW Union Electric Company d/b/a Ameren Missouri (Ameren Missouri or the Company) and for its *Request to Extend Date by Which it is Required to Provide LED Street Lighting Information* (Request), states as follows:

- 1. Ameren Missouri and the Missouri Public Service Commission Staff (Staff) entered into a *Stipulation and Agreement* (Stipulation) filed with the Commission on September 28, 2012 which resolved certain issues. The Commission approved the Stipulation by order dated October 10, 2012.
- 2. Paragraph four of the Stipulation resolved the LED street lighting issue for purposes of this case. Ameren Missouri accepted the recommendations of Staff witness Hojong Kang and agreed to complete and provide to Staff its evaluation of all issues the Company identified in its July 31, 2012 Report to Staff by no later than January 31, 2013. The Company further agreed to file an LED street lighting tariff or a status report by no later than March 31, 2013.
- 3. As Ameren Missouri has worked through the issues referenced in the Stipulation, it has become clear that the analysis required is more complex than it previously realized and that the Company will not have it completed by the January 31, 2013 deadline. Nor will Ameren Missouri be ready to file an LED tariff or a report by March 31, 2013.

- 4. Ameren Missouri asks the Missouri Public Service Commission to extend the dates previously approved. The Company asks to have until July 31, 2013 to complete its evaluation of all issues identified in its July 31, 2012 Report to Staff. Additionally, the Company requests to have until September 30, 2013 to file an LED street lighting tariff or status report. Between the time of this filing and the September 30, 2013 date, the Company agrees to meet (either in person or by telephone) with Staff at least every two months on this issue. The purpose of this meeting is to update Staff on the Company's progress and to allow Staff to comment on the work as it is in process.
- 5. Ameren Missouri has discussed this proposal with Staff and Staff has authorized the Company to inform the Commission that Staff does not object to the requested change to the Stipulation.

WHEREFORE, Ameren Missouri respectfully asks the Missouri Public Service Commission to issue an order modifying the dates related to the LED street lighting issue as set forth above.
