**SOUTH CENTRAL MCN LLC SUBMITTAL OF

FORM 1 ANNUAL REPORT**

**COMES NOW** South Central MCN LLC (SCMCN), by and through counsel, and hereby requests that the Commission accept the submittal of its Federal Energy Regulatory Commission (FERC) Form 1 and accompanying Independent Auditors Report. In support of its request, SCMCN states as follows:

1. On August 19, 2015, SCMCN filed an Application pursuant to Sections 393.170 and 393.190 RSMo., 4 CSR 240-2.060, 4 CSR 240-3.105, and 4 CSR 240- 3.110 for an Order of the Commission granting it a Certificate of Convenience and Necessity to own and operate certain existing transmission assets and related facilities that SCMCN is purchasing from the City of Nixa pursuant to an Asset Purchase Agreement (APA) (Appendix A to the Application) between SCMCN and Nixa or, in the alternative, authorizing SCMCN and Nixa to execute any and all documents necessary to effectuate the transaction in question.

2. On July 20, 2016, the Commission issued its Order Granting Certificate of Convenience and Necessity. At page 7 of the Order, the Commission required that when SCMCN files any annual report with the FERC, SCMCN shall file that annual report with the Commission. SCMCN filed its annual report with FERC along with its Independent Auditors Report on April 18, 2017.

3. Pursuant to that requirement, attached is a copy of SCMCN's FERC Form 1 for the end of the fourth quarter of 2016 as filed at FERC. Also attached is a copy of the Independent Auditor's Report relating to the FERC Form 1.

**WHEREFORE**, SCMCN therefore respectfully files its FERC Form 1 and accompanying Independent Auditor's Report as set forth above.
