SECOND AMENDED MOTION FOR EXPEDITED TREATMENT

COMES NOW South Central MCN LLC (SCMCN), and hereby submits this Second Amended Motion for Expedited Treatment pursuant to 4 CSR 240-2.080(14). In support thereof, SCMCN states as follows:

- 1. On August 19, 2015, SCMCN filed an Application pursuant to Sections 393.170 and 393.190 RSMo., 4 CSR 240-2.060, 4 CSR 240-3.105, and 4 CSR 240-3.110 for an Order of the Commission disclaiming jurisdiction under Section 393.190.1 RSMo. and confirming the inapplicability of 4 CSR 240-3.110 to a certain transaction including the transfer of the certain existing transmission assets to SCMCN by the City of Nixa (the City) pursuant to an Asset Purchase Agreement ("APA") between SCMCN and the City or, in the alternative, authorizing SCMCN and the City to execute any and all documents necessary to effectuate the transaction in question.
- 2. Also on August 19, 2015, SCMCN filed a Motion for Expedited Treatment, requesting that the Commission enter an order approving the relief requested by the Application by no later than October 30, 2015, in order for SCMCN and the City to consummate the Transaction effective December 1, 2015. That Motion is incorporated herein by reference.
- 3. On August 21, 2015, the Commission issued an Order Directing Filing of Recommendation regarding the Application by September 10, 2015, by the Staff.

- 4. On August 26, 2015, the City filed an Application to Intervene. On September 9, 2015, the Commission issued an Order Granting Intervention to the City.
- 5. On September 10, 2015, Staff, on behalf of itself and SCMCN, filed a Motion for Extension of Time to File Staff Recommendation, requesting a one-week extension until September 17, 2015. The Commission issued an Order granting the motion that same day.
- 6. On September 16, 2015, SCMCN and the City filed a Joint Motion for Extension of Time to File Staff Recommendation, requesting an additional four-week extension until October 15, 2015 in order to resolve certain outstanding issues. The Commission issued an Order granting the motion the same day.
- 7. On October 14, 2015, SCMCN and The City filed a Second Joint Motion for Extension of Time to File Staff Recommendation, requesting an additional three-week extension until November 5, 2015 to finalize certain outstanding issues.
- 8. SCMCN appreciates that, given the three requests for extensions of time totaling eight weeks, it would not be reasonable to expect the Commission to issue a decision on SCMCN's application by the December 4, 2015 date requested in the Amended Motion for Expedited Treatment.
- 9. Accordingly, if the Commission issues an order granting an extension of time to Staff to file its recommendation until November 5, 2015, SCMCN respectfully requests that the Commission enter an order approving the relief requested by the Application by no later than December 31, 2015.
- 10. There will be no negative effect on SCMCN's customers or the general public if the Commission acts by such date.

WHEREFORE, SCMCN therefore respectfully requests that the Commission enter an order approving the relief requested by the Application no later than December 31, 2015.
