On October 28, 2010, Missouri Gas Utility (MGU or Company) of Littleton, Colorado, filed tariff sheets requesting an effective date of November 11, 2010. The tariff sheets were filed to reflect changes in MGU's Purchased Gas Adjustment (PGA) factors as the result of estimated changes in the cost of natural gas for the upcoming winter season and changes in the Actual Cost Adjustment (ACA) factor. The winter season includes the months of November through March.

For MGU's Northern system (serving communities such as Hamilton and Gallatin), this filing will decrease the firm PGA factor for all firm customers for the upcoming heating season to \$0.5414 per hundred cubic feet (Ccf), from the current firm PGA factor of \$0.6340 per Ccf. This represents a decrease of \$0.0926 per Ccf for all firm customers.

For MGU's Southern system (serving communities such as Warsaw and Cole Camp), this filing will increase the firm PGA factor for all firm customers for the upcoming heating season to \$0.6059 per Ccf, from the current firm PGA factor of \$0. 5666 per Ccf. This represents an increase of \$0.0393 per Ccf for all firm customers.

Case No. GR-2011-0117, under which these changes were consolidated into and filed, was established to track the Company's PGA factors to be reviewed in its 2009-2010 ACA filing. These rate changes should be on an interim, subject to refund status pending a final Commission decision in ACA Case Nos. GR-2011-0117.

Due to the limited time available to review the documentation supporting the ACA factor represented in this filing, the Procurement Analysis Department (PAD) has requested permission to submit its results and recommendations regarding the information included in this ACA filing to the Commission on or before December 31, 2011.
