

COMES NOW the Director of the Division of Manufactured Homes, Recreational Vehicles and Modular Units of the Public Service Commission ("Director" and "Commission"), on behalf of himself and Discount Manufactured Housing, Inc. ("Discount"), and the Office of the Public Counsel ("OPC") and for the *Statement of Settlement* in this case states as follows:

1. On May 15, 2001, the Commission issued its *Order Establishing Procedural Schedule* in this case. In that order, the Commission set an evidentiary hearing in this matter for July 31, 2001.


2. However, this day the Director and Discount have reached a mutually agreeable settlement of the issue in the case that makes an evidentiary hearing unnecessary. Therefore, the Director and Discount would request that the hearing be cancelled. OPC does not object to this request.

3. The Director and Discount will file a formal *Stipulation and Agreement* memorializing the terms of the settlement for consideration by the Commission on or before August 14, 2001.

**WHEREFORE**, the Director, on behalf of himself and the other parties to this case, prays that the Commission accept this *Statement of Settlement* and cancel the evidentiary hearing set for July 31, 2001. All of the parties further pray that the Commission make whatever other order and judgments it deems just and proper in this cause.
