STAFF'S STATUS REPORT ON STATE NUMBER POOLING TRIALS

COMES NOW the Staff of the Missouri Public Service Commission and for its report states:

1. On September 25, 2001, the Commission issued an Order Directing State Number Pooling Trials which ordered state number pooling trials in the 314 and 816 NPAs and which directed the Staff to file periodic reports advising the Commission of the status of the 1,000s block number pooling trials, when the trials are fully implemented and when the trials are ended and moved into the national number pooling program.

2. On February 27, 2002, the Staff reported to the Commission that the state number pooling trials were successfully implemented in the 314 and 816 NPAs on the mandated start dates.

3. On March 19, 20002, a representative of NeuStar, the national pooling administrator, issued the following message:

NeuStar Number Pooling Services is pleased to announce that all state number pooling trials were successfully migrated to the national Pooling Administration System (PAS) on schedule this past weekend. All state pooling trials are now part of the national number pooling system.

WHEREFORE, the Staff reports that the 314 and 816 NPA state number pooling trials have been moved into the national number pooling program.
