I am writing as Secretary of Lockheed Martin Global Telecommunications Services, Inc. 52-2271154 to confirm the 2001 announcement made by Lockheed Martin Corporation of the plan to exit its Global Telecommunications services business including reassigning certain of the former Lockheed Martin Global Telecommunications (LMGT) businesses to other operating segments of Lockheed Martin, discontinuing activity as a common carrier, and selling the remaining operations.

Shortly thereafter, Lockheed Martin arranged with AT&T for provision of service and to bill directly the customers of Lockheed Martin Global Telecommunications Services, Inc. (LMGTSI). This and other activity culminated in the subsequent closing of the books of LMGTSI concurrent with transfer of closure responsibility.

Additionally, we are completing the steps necessary to file final returns, surrender the carrier certificates, withdraw corporate registrations in various states, and finally to dissolve LMGTSI.
