## STAFF'S STATEMENT OF POSITION

COMES NOW the Staff of the Missouri Public Service Commission and states:

- 1. The Commission's March 26, 2007 Order Setting Procedural Schedule directs the parties to file, no later than August 7, 2007, a List of Issues, List of Witnesses, Order of Cross-Examination, and Order of Opening Statements, and to file their respective Statements of Position by August 13, 2007.
  - 2. The parties filed an agreed upon List of Issues on August 7, 2007.
  - 3. The Staff states its position on those issues:
    - Issue 1. Should the Commission approve CenturyTel of Missouri, LLC's and Spectra Communications Group, LLC d/b/a CenturyTel's (collectively "CenturyTel") tariff filings to grandfather Remote Call Forward ("RCF") service to existing customers and existing locations?

      Staff's Position: No. RCF is useful to businesses that want to provide local numbers for customers to call without the businesses actually having a physical presence in the local area. RCF can also be useful in response to natural or man-made disasters because the service

allows a customer to retain the same telephone number and have calls

redirected to another location. Technological obsolescence is one reason

to grandfather a service, but RCF is not obsolete. (Voight Rebuttal, pp. 2-6)

**Issues 2.** Should the Commission require CenturyTel to fulfill Socket Internet's orders for RCF service submitted after the tariff filings, before being allowed to grandfather that service?

**Staff's Position:** Yes. These orders were submitted while CenturyTel's RCF tariff sheets were still in effect. (Voight Rebuttal, pp. 6-7)
