JOINT MOTION TO AMEND PROCEDURAL SCHEDULE

COME NOW the Parties to this case and respectfully request that the Commission amend the existing procedural schedule as follows:

1. In accordance with the Parties' Second Motion to Establish Procedural Schedule and the Commission's Order Adopting Procedural Schedule issued February 17, 2006, the existing schedule provides:

If there is agreement by the Parties, then:

March 15, 2006	Submit Stipulation
March 20, 2006	Presentation of Stipulation to Commission (if desired)

If there is no agreement among the Parties, then:

March 23, 2006	List of Issues
March 30, 2006	Statement of Positions, List of Witnesses, Order of Witnesses
April 6, 2006	Hearing

2. The Parties are continuing discussions to reach agreement and submit a Stipulation in this matter; however, the Parties will not be able to meet the current deadline for submission of a Stipulation. In addition, the Parties are aware of the

Commission's recent order issued in Case No. EA-2006-0309 setting two local public hearings on March 20, 2006, the date currently set for the presentation of the Stipulation.

3. Accordingly, the Parties recommend that the current procedural schedule be amended in the following manner:

If there is agreement by the Parties, then:

March 29, 2006	Submit Stipulation
April 6, 2006	Presentation of Stipulation to Commission (if desired)

If there is no agreement among the Parties, then:

April 6, 2006	List of Issues
April 13, 2006	Statement of Positions, List of Witnesses, Order of Witnesses
April 20-21, 2006	Hearing

4. The Commission's rule at 4 CSR 240-2.050(3) provides that the Commission may order a period enlarged before the expiration of that period if an act is required or allowed to be done by order of the Commission.
