
STAFF RECOMMENDATION


On January 10, 2000, NYNEX Long Distance Company (NYNEX) d/b/a Bell Atlantic Business Services, a competitive interexchange telecommunications company, filed a proposed replacement tariff which reflects NYNEX's name change from NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance to NYNEX Long Distance Company d/b/a Bell Atlantic Business Services. Included with the tariff filing is a copy of NYNEX's Registration of Fictitious Name from the Missouri Secretary of State. Bell Atlantic Communications, Inc. name was changed to NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance in Case No. TO-98-271.

According to the cover letter, NYNEX made no other changes to the proposed replacement tariff other than change the corporate name. The Telecommunications Department Staff (Staff) has no objections to the proposed tariff, as amended, and recommends the Commission issue an order to amend NYNEX's certificate of service authority to provide interexchange telecommunications services and approve the following tariff pages effective February 10, 2000:
