

Comes now the Staff of the Missouri Public Service Commission ("Staff"), pursuant to 4 CSR 240-2.050(4), and for its Motion for Extension of Time states that:

1. 4 CSR 240-2.050(4) provides in part:

When an act is required or allowed to be done at or within a specified time, the commission may, at its discretion: (A) Order the period enlarged if a request is made before the expiration of the period originally prescribed. . . .

2. By Order issued on July 15, 1988, the Commission retained in the above-captioned consolidated cases Public Counsel's proposed procedural schedule for Case No. TA-88-218.

3. Said procedural schedule requires the Staff, Public Counsel and the Intervenor to file their respective direct testimony on August 12, 1988.



4. In order to have sufficient time to thoroughly and properly analyze the direct testimony filed on August 5, 1988, Staff requests a one week extension to August 19, 1988 for the Staff, Public Counsel and the Intervenors to file their respective direct testimony. 5. Counsel for Staff has conferred with counsel for all parties hereto, including counsel for those with applications to intervene now pending before the Commission, and none object to Staff's request.
