**STATEMENT OF NOTICE PROVIDED**


**COMES NOW** Applicant, Aqua Missouri, by and through counsel, and for its Statement states as follows:

1. The parties to this matter agreed upon a form notice to be set to all customers of Aqua Missouri regarding the proposed transaction in the above-captioned matter. A copy of that notice is attached to this pleading as Exhibit A.
2. On January 7, 2011, The notice was installed in the Aqua Missouri system to be provided in bills at the next billing date for each customer.
3. On January 10, 2011, notices were mailed to 642 customers of Aqua Missouri and on January 11, 2011, notices were mailed to 192 customers of Aqua Missouri.
4. On February 1, 2011, notices will be mailed to approximately 1,998 customers of Aqua Missouri for the final January billing cycle.


