**STATEMENT OF POSITION**

**COMES NOW**, Union Electric Company d/b/a AmerenUE (“AmerenUE”), a Missouri corporation, and for is Statement of Positions on the Issue in the above-styled case, respectfully states as follows:

1. The controversy in this case is whether or not Damon Andersson is responsible for a final bill for electric service provided to 111 E. Pitman Street in O’Fallon, Missouri. The amount of this bill is \$795.20.


2. It is the position of AmerenUE that Mr. Andersson is responsible for the bill as the customer of record. Mr.Andersson had the service put in his name on November 10, 2000 and he remained the customer of record until a new resident requested service be transferred on February 28, 2002.

3. Alternatively, as Mr. Andersson resided at this address during the time that the bill was incurred, he is also responsible as an individual who obtained the benefit of electric service.

4. Finally, while AmerenUE recognizes that other individuals may have resided at 111 E. Pitman, it is the Company's position that Mr. Andersson is not without remedy against these individuals. Any dispute between these individuals as to the sharing of the final bill is not a matter appropriately before the Commission, but rather is an issue that should be dealt with outside of the Commission, such as in Small Claims Court.
