ORDER CANCELING CERTIFICATE AND TARIFF

This order cancels the certificate of service authority to provide interexchange and nonswitched local exchange telecommunications services granted to Telegenius, Inc., along with its accompanying tariff.

On April 29, 2005, the Staff of the Missouri Public Service Commission filed its motion to open a case and cancel Telegenius's certificate of service authority. Staff stated that the Commission granted Telegenius a certificate of service authority to provide intrastate interexchange telecommunications services in Case No. TA-2002-209. The Commission also approved Telegenius's tariff, P.S.C. MO No. 1, in that same case.

Staff states that Telegenius is the subject of the complaint case, Case No. TC-2004-0313, in which Telegenius defaulted before the Commission. That complaint case, TC-2004-0313, is the subject of a suit, Case No. 04CV324714, at Cole County Circuit Court. Telegenius defaulted before the Circuit Court. Staff also notes that the Missouri Secretary of State's website indicates that Telegenius is a foreign corporation and was dissolved on October 22, 2004. For these reasons, Staff recommends that Telegenius's certificate and accompanying tariff be canceled.

The Commission has the authority to cancel a telecommunications corporation certificate under Section 392.410.5, which states, "Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected." Since no one has requested a hearing in this case, the Commission may grant the relief requested based on the application.

The Commission has reviewed the motion and finds that it is reasonable to cancel Telegenius's certificate of service authority. In addition, the Commission finds that it would be in the public interest to cancel the tariff of the company. Therefore, the certificate of service authority granted to Telegenius in Case No. TA-2002-209, along with its accompanying tariff, will be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of service authority granted in Case No. TA-2002-209 to Telegenius, Inc., along with its accompanying tariff, P.S.C. MO No. 1, is canceled.
2. That this order will become effective on June 11, 2005.
3. That this case may be closed on June 12, 2005.
