**MOTION TO OPEN CASE AND CANCEL
CERTIFICATE OF SERVICE AUTHORITY**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificate of Service Authority respectfully states as follows:

1. On November 4, 1994, the Missouri Public Service Commission granted a certificate of service authority to provide shared tenant services to QCC, Inc, (QCC) in Case No. TA-95-68.

2. On May 17, 1995, in TO-95-365, the Commission issued an Order Indicating Change of Corporate Name, the case was established to memorialize the submittal of an adoption notice wherein Qwest Communications Corporation changed its name to QCC, Inc. Such order also provided for adoption of Quest's tariff, P.S.C. Mo. No. 1.

3. On December 23, 1997, the Commission granted a certificate of authority to provide basic exchange and local exchange intrastate telecommunications services to QCC in Case No. TA-97-380.

4. On July 22, 1998, the Commission approved Mo. P.S.C. No. 2 tariff in Case No. TA-97-380.

5. On July 16, 2003, the Commission received a letter advising that QCC has ceased operations in the State of Missouri and requesting cancellation of any tariffs. A copy of said letter is attached hereto as "Appendix A" and made a part hereof.

6. On July 15, 2004, QCC was administratively dissolved by the Missouri secretary of state for failure to file a correct and current annual report.

7. Staff has made an investigation and it has been determined that QCC owes no annual reports or assessments. No other matters are pending in front of the Commission.

8. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5, RSMo 2000, which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

WHEREFORE, the Staff recommends the Commission issue an order canceling the certificates of service authority of QCC and its accompanying P.S.C. Mo. No. 1 and Mo. P.S.C. No. 2 tariffs.
