MOTION TO CANCEL CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

COMES NOW, the Staff of the Missouri Public Service Commission and moves for the Missouri Public Service Commission (Commission) to cancel the certificate of competitive basic local and interexchange telecommunications service authority in Missouri of Trans National Communications International, Inc. ("the Company") and states as follows:

1. On October 30, 1999 and February 20, 2005, the Commission granted certificates of interexchange and competitive basic local telecommunications service authority to the Company in Cases No. TA-2000-237 and CA-2005-0133, respectively. It has existing approved tariffs, JX-2010-0670, JC-2010-0666 and JC-2010-0667.

2. On April 22, 2014, the Company notified the Commission that it intended to cancel its certification to provide telecommunications services in Missouri, but never made a filing to that effect.

The Company did not make requisite annual filings.

3. The Commission has the authority to cancel a telecommunications certificate pursuant to Section 392.410.5 RSMo 2000, which provides “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

4. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. W.D. 1989).

WHEREFORE, the Staff respectfully recommends the Commission cancel the certificates of service authority of Trans National Communications International, Inc. to provide competitive basic local and interexchange telecommunications service in Missouri and its tariffs.
