On June 30, 2023, Missouri Telecom, Inc., filed a letter requesting that its certificates of service authority to provide basic local, nonswitched local, and interexchange telecommunications services be cancelled. Missouri Telecom states that its authority was granted in File Nos. TA-99-549 and XA-2004-0176. Missouri Telecom also requested that any tariffs it has on file be canceled, including Missouri Local Exchange Telecommunications Tariff of Missouri Telecom, Inc. (00-489, Missouri PSC. No. 1), and Missouri Interexchange and Nonswitched Local Exchange Telecommunications Tariff of Missouri Telecom, Inc. (Tracking No. YX-2004-0486, PSC Mo. No. 2).

The Commission will direct its Staff to file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. No later than July 13, 2023, Staff shall file either its recommendation or a status report indicating when it expects to file its recommendation.

2. This order is effective when issued.
