JOINT RECOMMENDATION

COME NOW Xspedius Management Co. of Kansas City, LLC ("Xspedius KC", and Applicant in Case No. CA-2007-0473), and **Xspedius Management Co. Switched Services, LLC** ("Xspedius Switched Services"), (collectively referred to as "Joint Applicants" in Case No. TM-2007-0472) and Staff of the Missouri Public Service Commission, by their undersigned counsel, and hereby submit these Joint Recommendations to assist the Commission in review and resolution of the multiple tariff filings related to these cases. The complexity of these tariff filings may result in some confusion reflected in the Staff Recommendation filed on July 30, 2007, and Staff and Joint Applicants wish to cure any confusion by providing a clear outline of the pending tariff matters and their recommendation for Commission action on those tariffs.

Tariff Revisions and Cancellation

These tariff revisions and cancellation are recommended by Staff and Joint Applicants:

1. **Xspedius KC -- IXC and LE Services Tariff:**

Missouri P.S.C. Tariff No. 1

This tariff was requested to be cancelled upon merger per Supplement to Applications filed by the Joint Applicants on July 13, 2007 in TM-2007-0472 and CA-2007-0473. However, Staff and Joint Applicants have determined there is no need to wait until the merger takes place to cancel Tariff No. 1. Thus, it is recommended that the Commission's order in TM-2007-0472 include cancellation of this tariff effective on August 11, 2007, along with other associated tariff revisions; or, if the Commission prefers, it may delay action regarding this request until it is advised the merger has taken place.

No separate tariff filing in EFIS was made, so there is **no tariff tracking number** associated with this request.

2. **Xspedius KC -- Access Service Tariff:**

effective August 11, 2007, should be approved.

Associated **Tariff Tracking No. YX-2008-0018** -- This is a name change only; no adoption notice needed because it is a current tariff of the company that will be the surviving entity in the merger case.
