### **SUPPLEMENTAL RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff") and for its Supplemental Recommendation, states as follows:

- 1. On April 8, 2021, the Commission held an evidentiary hearing in the matter of Missouri-American Water Company's ("MAWC") Application requesting a Certificate of Convenience and Necessity ("CCN") to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in and around the City of Hallsville, Missouri ("City"), as an addition to MAWC's existing service territories.
- 2. During the hearing, the Commission heard testimony concerning the City's current volumetric rates, based on water usage, of \$19.35 for the first 1,000 gallons, with an additional charge of \$5 for every additional 1,000 gallons. MAWC proposed to adopt these rates in its Application.
- 3. However, the feasibility study attached to MAWC's Application specified a different rate, which was a flat charge of \$38.75 for residential customers.
- 4. MAWC witness Matthew Horan testified that the Application incorrectly stated that MAWC was going to adopt the current City rate, and that MAWC always intended to move to the

flat charge of \$38.75. Mr. Horan further clarified that the \$38.75 flat charge was the current rate MAWC charged small sewer systems outside of the City of Arnold, per its Commission-approved tariffs. <sup>2</sup>

- 5. In addition to including the flat rates in its feasibility study, Mr. Horan also clarified that MAWC advertised the flat rate of \$38.75 to the voters of the City prior to the vote to sell the sewer system on November 5, 2019.<sup>3</sup> Those advertisements are attached hereto as Appendix A.
- 6. The Commission heard testimony from Mayor Logan Carter that flat rates of (1) \$38.75 for residential, (2) \$43.75 for commercial, and (3) \$164.75 for high commercial<sup>4</sup> were to be subject to approval by the City, via vote by its Board of Alderman, on April 12, 2021.<sup>5</sup> Mayor Carter also confirmed that MAWC had always promoted the flat rate of \$38.75 as its intended rate.<sup>6</sup>
- 7. When questioned about the difference between the two rates, Staff witness James Busch testified that Staff had no problem with either rate. Mr. Busch also testified that:

[S]ince its volumetric rate that is currently in effect for the City of Hallsville, for Missouri-American to do a feasibility study they would have to come up some level of monthly income. So based upon what the current rates are for Hallsville, like I said, if a customer uses 4,000 gallons it's right around \$34. If they use 5,000, it's around \$39. So 38.75 is probably a good proxy as an average for all those customers for the feasibility study instead of having different rates, or different monthly rates for the citizens.<sup>8</sup>

- 8. Upon hearing that the City system received water from Public Water District No. 4, Mr. Busch added "that going with a flat 38.75 might be better because it may be more difficult for Missouri-American to obtain the water readings from the water District."
- 9. On April 23, 2021, the Commission issued its *Order Directing Filing and Suspending Briefing Schedule*, ordering (1) MAWC to file documentation confirming the status of and description of any new rate structure in place or to be adopted by the City no later than April 30, 2021, and (2) ordering Staff to file a supplement to its recommendation concerning the flat rate structure no later than May 10, 2021.
- 10. MAWC filed City Ordinance No. 384 (Bill No. 2021-2), passed and effective on April 12, 2021, showing the new flat rate of:
  - a. \$38.75 for residential customers within the city limits;
  - b. \$43.75 for residential customers outside the city limits;
  - c. \$48.75 for low usage commercial, public authority, and industrial customers within the city limits (use less than 12,500 gallons per month);
  - d. \$53.75 for low usage commercial, public authority, and industrial customers outside the city limits;
  - e. \$159.75 for high usage commercial, public authority, and industrial customers within the city limits (use more than 12,500 gallons per month); and
  - f. \$164.75 for high usage commercial, public authority, and industrial customers outside the city limits.
- 11. When conducting its review of MAWC's Application, auditing Staff had already evaluated the transaction and feasibility of the flat rate of \$38.75 outlined in the feasibility study.

In its Recommendation, Staff notes that the pre-existing City rates cited in the Application would likely change in MAWC's next general rate case, and were therefore irrelevant to the long-term economic feasibility of the acquisition.<sup>10</sup> MAWC utilized the \$38.75 flat rate to project the net income of the existing City system under MAWC's cost structure, and Staff made a determination based on those assumptions and figures.<sup>11</sup>

12. Further, in *Missouri-American's Response to Staff's Recommendation*, filed on December 4, 2020, MAWC indicated that, "Provision for the possibility of flat rate billing may need to be made in the resulting tariff to address any situation where Missouri-American is unable to obtain the referenced meter reads." As noted during the evidentiary hearing and in this pleading, MAWC would have to obtain these reads from Public Water District No. 4.

13. Thus, the City approval of the flat rate structure, resulting in rates similar to those under the volumetric model prior to April 12, 2021, does not alter Staff's ultimate recommendation to approve MAWC's Application at this time.

**WHEREFORE**, Staff respectfully submits this *Supplemental Report* for the Commission's information and consideration.


