On September 29, 2021,<sup>1</sup> the Commission issued an Order Granting Certificate of Convenience and Necessity which, in part, ordered Mid Mo Sanitation LLC (Mid Mo) to submit newly created and/or revised tariff sheets that included an updated map and legal description to reflect its authority to operate its sewer system in the land application area for which the Order granted a certificate of convenience and necessity. On October 7, Mid Mo filed Tariff Revision YS-2022-0074 with a November 6 effective date. The Commission will order the Commission's Staff to file a recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. No later than October 15, 2021, the Commission's Staff shall file a recommendation concerning Tariff Revision YS-2022-0074.
  - 2. This order shall be effective when issued.
